Bethany Children's Home awarded prestigious designations

(Womelsdorf, Pa., Nov. 9, 2020) – Bethany Children's Home has earned The Joint Commission's Gold Seal of Approval® for Behavioral Health Care and Human Services Accreditation by demonstrating continuous compliance with its performance standards. The Gold Seal is a symbol of quality that reflects a health care organization's commitment to providing safe and quality patient care.

Bethany Children's Home underwent a rigorous review in September. During the review that spanned several days, a team of Joint Commission reviewers evaluated compliance with Behavioral Health Care and Human Services standards spanning several areas including emergency management, environment of care, infection prevention and control, and medication management, among others.

The Joint Commission's standards are developed in consultation with health care experts and providers, measurement experts and patients. They are informed by scientific literature and expert consensus to help health care organizations measure, assess and improve performance. The surveyors also conducted observations and interviews.

“As a private accreditor, The Joint Commission surveys health care organizations to protect the public by identifying deficiencies in care and working with those organizations to correct them as quickly and sustainably as possible,” says Mark Pelletier, RN, MS, chief operating officer, Accreditation and Certification Operations, and chief nursing executive, The Joint Commission. “We commend Bethany Children's Home for its continuous quality improvement efforts in patient safety and quality of care.”

Services Act, signed into law in 2018. Team members have gone through extensive training as part of this certification.
